High School Report:

Cindy Christoferson shared:

- We are gearing up for student conferences beginning tomorrow.
- Mrs. Brown will be in the auditorium tomorrow night to share FAFSA information with students and families.
- Some upcoming things happening at the high school include:
 - Field trip to Sno-Isle Skills Center Open House the evening of Thursday, November 3rd.
 - High School Veterans Day assembly will be held on Thursday, November 10th at about 2
 PM

Cindy Christoferson shared:

• The special education rate is currently 69/426 or 16.2%.

K-8 School Report:

Tracy Franke reports:

- North Cascade Park Rangers hosted 5th grades for a short hike and museum scavenger hunt with help from GPI and parent volunteers.
- Ashley at the library gave 5th graders a tour of the library, how to use it, and a story time.
- We made 30 plus loaves of pumpkin bread.
- We are looking for more Mystery Readers from the community if anyone would like to share a picture book or page from a chapter book that impacted them in their youth.
- Tier II and Tier III interventions are in place to support student learning. This is being supported by a 'push-in' model and a 'pull-out' model.

Superintendent Report:

Tracy Franke shares:

- Time and Effort- I want to inform you that in our district, if we have staff members who
 are paid out of federal funds, such as Title I, and local monies, like Basic Ed or LAP, a
 Time and Effort document is created to identify the time spent on tasks that can be paid
 out of that specific fund.
- Facilities
 - Small Rural Schools Modernization Grant We applied for this grant a few years ago. We should know in the spring if we will be receiving funds this year.
 - Department of Commerce Grant for moving to eclectic from fossil fuels. This
 grant could cover items that we had to remove from the Modernization Grant
 - We received our renewal permit for our large on-site septic system.
 - Bark/dirt was delivered and spread over the flower beds.
 - We are moving forward with in-ground irrigation system
- Food Service
 - We have added a dishwasher position in the cafeteria (three hours per day) to support the increase in the number of meals being served.
 - We passed our health inspection.
- Curriculum Adoptions
 - Shawna Brown is facilitating curriculum adoption committees for social studies and math.
- Transitional Kindergarten
 - We will begin the process to start the program, inform the community of their options, accept applications, and administer assessments to determine eligibility.

Financial and Enrollment Reports:

McKenzie Boyd shares that enrollment has gone down for October, but is still well above budget. The year-end closing process is done and the ending fund balance is about \$1.1 million, which is typical for the district.
